## Board Removes COVID Operating Restrictions


#### **Pool/Park Reservation Requests Now Being Accepted!**

Thanks to all who put in their time on Work Day. You will be exempt from the \$40 Work Day Assessment. If you did not work and have not made other arrangements to put in time individually, there will be an additional \$40 on your statement for Third Quarter in addition to the increase in the quarterly assessment amount.

There have been some concerns about assessment payments arriving past the grace period and earning a late fee. As a reminder, the due date for payment is the 1st of the month, and the 15th is a grace period to allow for delayed mail. To avoid a late penalty, we suggest mailing (or setting your direct payment) prior to the 1st rather than waiting until closer to the 15th.
