
# President Brenda Shaw

## **Dog Waste NOTICE**

3.15.2022

TO: ALL RESIDENTS OF EVERGREEN COMMONS HOA

FROM: ECHA BOARD MEMBERS

Numerous complaints have been received from residents of the community regarding unleashed dogs and dog waste in the ECHA Park. There has been an increased volume of dog waste that has been found on the common park area owned by the HOA. If you are a dog owner, please be respectful of your neighbors' property as well as the common grounds of the Association.

#### **Sacramento County Leash Laws**

9.44.220 Prohibited conduct

No owner of any animal, wild or domestic, except the domestic cat, shall permit or suffer such animal to do any of the following things:

- Be at large. The definition of "at large" is set forth in Section 9.44.020 (when it is off the premises of its owner, and not under restraint by leash, tether or adequate enclosure).
- Defecate upon public property, or upon the private property of another, unless the owner immediately removes the feces and properly disposes of the feces by placing it in a closed or sealed container and depositing it in a trash receptacle.

All dog owners are urged to abide by the law so that the unsightly and unhealthy appearance of dog waste on the grounds can be eliminated. Please be reminded that pet owners who fail to abide by the County Law can be fined by the ECHA Board or the County and in cases of repeated violations, the pet can be deemed a public nuisance in which case the County can remove the pet from the premises. If you observe a dog walker not picking up after the dog's waste, please report it to the Evergreen Commons Board as soon as possible.

All residents are asked to take pride in the community by adhering to the community rules and County Law regarding keeping your dog on leash and the disposal of pet waste. If all pet owners within the community practice proper pet waste disposal as mentioned above, the eyesore and health hazard created by pet waste on the community grounds can be eliminated.
